

## TERMS AND CONDITIONS

1. Participation in this Canon Australia Christmas Promotion (**Promotion**) is deemed acceptance of these Terms. Information and instructions on how to participate form part of these Terms.
2. The Purchase Period starts on 15 October 2018 and closes 06 January 2019 (**Purchase Period**).

## Eligibility

3. The promotion is only open to individual Australian residents, who are not employees (or their immediate family members) of the Promoter, its related companies or agencies associated with this Promotion (**Participants**). Participants under the age of 18 must have the consent of their parent or legal guardian to enter this Promotion and to agree to its Terms.

## Prize

4. The “**Prize**” is a holiday to the destination selected by the Participant when submitting the entry form (**Holiday**) plus AUD\$1,000 spending money. There are 30 Prizes to give away as per the table in clause 8 below. These will be awarded in ten separate Prize Draws (one draw per Holiday destination).
5. Each Prize is subject to the MTA (travel service provider) terms and conditions. See website for Terms applicable to each Prize ([www.canon.com.au/holidays](http://www.canon.com.au/holidays)) (**Website**). This includes requirements for passport validity and visa applications.
6. If the winner is under the age of 18, their parent or guardian must accompany them on the Holiday.
7. To be eligible to claim a Prize, The Participant (and their chosen partner/s) must have or be able to obtain a valid passport in time to travel together with appropriate visas for their chosen destination. Passports must have at least 6 months validity from date of return to Australia.

9. A “**Child**” is a person 12 years of age or under.
10. The winner (and their chosen partner/partners) must be available on the particular dates specified on the Website for the Holiday they choose in order to be eligible to claim that Prize. However, the winner acknowledges that due to the nature of the Prize, dates may change for reasons outside the reasonable control of the Promoter. In such case, the winner (and their chosen partner/partners) must be available on any substitute dates provided by the Promoter or its contractors.

## How to Enter

11. During the Purchase Period, Participants must purchase any Canon “**Eligible Product**” listed in the table at the end of these terms from an Authorised Canon Australia retailer. Each Eligible Product provides the Participant with a specified number of entries for the Holidays listed in the table in clause 8.
12. Canon-branded products that have been sourced by end-users, distributors or retailers from any source other than through Canon Australia’s official online store or from an authorised Canon Australia retailer in the Canon Australia Distribution Channel (including ‘grey’, ‘parallel’ or ‘direct’ imports) are not Canon Australia products and do not constitute Eligible Products. To find out more, see the Website.
13. After payment, Participants must go to the Website and complete the form no later than 20 January 2019 by:
  - a. entering their details;
  - b. allocating their entries to the Holiday(s) they want to win; and
  - c. uploading a copy of their proof of purchase (showing the Eligible Product or Eligible Products they have purchased during the Promotion Period) or mail a copy of their proof of purchase together with a printed copy of the completed Claim form to “Canon Promotions, PO Box 610, Artarmon, NSW 2064” in time to be received by last mail on 25 January 2019.
14. If several Eligible Products are purchased in the same transaction, only one entry form is required to be submitted.

Alternatively, if multiple purchases on different occasions are made, then a separate form per transaction is required to be submitted. The Participant can allocate each individual entry they receive to a different Prize Draw.

15. Once Participants have submitted the form, no changes can be made (i.e. Participants cannot reallocate their entries to different prize draws.)

### Prize Draw

16. Separate draws will take place for each Holiday destination. The draw and the announcement of the prize winners will be scrutinised by an independent person and will commence at 10am (AEDST) 7 February 2019 at the head office of Anisimoff Legal, Suite 5, Erina Plaza, 210 Central Coast Highway, Erina NSW 2250 subject to any directions from a regulatory authority. The first valid entry drawn will win the Holiday. If several Holidays are available in that Prize Draw, then the Promoter will continue to draw entries until all Holidays in that Prize Draw have been allocated.
17. The winner for each Holiday will be notified via email or phone call on the day of the prize draw and their name will be published on 8 February 2019 on the Website.
18. The winner may be required to provide personal information (such as a home address) in order to claim the Holiday.
19. If the winner does not claim the Holiday by the time indicated by the Promoter in the notification, or if a winner cannot be contacted as specified in these Terms, or cannot provide suitable proof as to Eligibility, or compliance with these Terms, he/she will forfeit the Holiday.
20. If the winner forfeits the Holiday, secondary draws may take place at 10am (AEDST) 21 February 2019 at the head office of Anisimoff Legal, Suite 5, Erina Plaza, 210 Central Coast Highway, Erina NSW 2250, subject to any directions from a regulatory authority. The winner will be notified via email or phone call within two days of the secondary draw and their name will be published on 7 March 2019 on the Website.
21. The Holiday, or any unused portion of a Holiday, is not exchangeable and cannot be taken as cash.

### Participant's Warranties and Indemnity

22. The Promoter is not liable to Participants for any costs or claims arising from a breach of these Terms.
23. Each Participant is fully responsible for any costs required for or associated with entering this Promotion (eg. Internet access).

### Conditions that may Invalidate Entries, Participants or the Promotion

24. The Promoter reserves the right to disqualify any Participant where it reasonably suspects that the Participant fails to comply with relevant law, breaches these Terms, or has failed to meet the Eligibility criteria.
25. If the Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated by the Promoter, the Promoter reserves the right to the fullest extent permitted by law and subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion.
26. The right to enter or take the Prize is forfeited if the Participant returns the relevant Eligible Purchase under any 'Peace of Mind' policy.

### Collection of Personal Information

27. The Promoter collects Personal Information in order to conduct the Promotion. The Promoter may, for the purposes

of conducting the Promotion, disclose such information to third parties, including agents, contractors, service providers, suppliers and, as required, to regulatory authorities. Personal information collected by the Promoter in connection with this Promotion will be managed in accordance with its Privacy Policy (available at [www.canon.com.au/privacy-policy](http://www.canon.com.au/privacy-policy)).

### Liability

28. The Promoter uses a commercially reasonable level of skill and care in providing the Promotion digital platforms and running the Promotion. However, as with any digital service, the Promoter cannot guarantee that these will be live or error free at all times.
29. The Promoter will not be held responsible for any changes or modifications to the Prize, including but not limited to, changes to flights, accommodation, or specific destinations. The Promoter reserves the right to amend any Holiday or substitute elements of any Holiday with those of similar value.
30. Nothing in these Terms limits, excludes, modifies, or, purports to limit, exclude or modify the statutory consumer guarantees under the *Competition and Consumer Act*, as well as other implied warranties under any legislation in Australia (**Non-Excludable Guarantees**). Except for any liability that cannot be excluded by law, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability for any personal injury or any loss or damage (including loss of opportunity) – whether direct, indirect, special or consequential – arising in any way out of the promotion, including (without limitation) out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any late, lost, altered or misdirected entries (whether or not after their receipt by the Promoter) due to any reason beyond the control of the Promoter; or (d) any tax liability incurred by a Participant.

### General

31. All money amounts in these Terms are in Australian Dollars inclusive of GST.
32. If any provision of these Terms is unenforceable for any reason, such provision shall be severed from these Terms and the remaining Terms will remain in full force and effect.
33. These Terms are governed by the laws in New South Wales. All Entrants submit to the non-exclusive jurisdiction of the Courts of New South Wales.
